

Grant Application Guidelines Hasanah Special Grant 2024

1.1 BACKGROUND

Yayasan Hasanah’s (“Hasanah”) vision is to catalyze social impact at scale for a more inclusive and progressive Malaysia. We do this through our grants programme in five impact areas which are Education, Community Development, Environment, Arts and Public Spaces and Knowledge. These impact areas are anchored on Hasanah’s core foundation of long-term nation building; and built on Hasanah’s commitment to stakeholders in upholding the values of *empowerment, trust, integrity, inclusivity, connectedness and authenticity*.

Hasanah works through an ecosystem of champions that include civil society partner organisations, social enterprises, government and regulatory agencies, and the community, where we strive to ensure cohesive, holistic and impactful initiatives on the ground. Our champion-ecosystem is intentionally local. This is part of our strategy to sustain and strengthen the local community’s capacity, ownership and leadership, and to ensure solutions are customised and relevant to local needs.

We emphasise an operational model of equal partnership. Our role is to complement and support the passion and goal of our partners that are aligned to our own Theory of Change, and build our collective capacities to strategise, lead, and open doors to policy-making in our respective areas of work.

Hasanah has supported interventions that are not only transformative and catalytic, but also interventions which have had meaningful social impact on both the nation and the communities it serves. Achieving significant and multi-faceted social impact however requires a longer time horizon.

For the year 2024, Hasanah is honoured to be given the opportunity to collaborate again with the Ministry of Finance (“MOF”) in providing matching grants, using Hasanah’s grant platform to expand the reach of grants and impacts, as well as to reach people in need across the country.

We welcome proposals that are clearly aligned with Hasanah’s mandate and support any of Hasanah’s five Impact Areas. Other considerations include scalability, replicability and deepening of the project, opportunities to advocate for policy change for the better, how its impact can transform or catalyze further progress in the affected issue or area, as well as the sustainability of the project. All projects for this grant cycle will be reviewed based on our priority areas and our five year Theory of Change 2020-2025 aspirations. We encourage you to read these properly to ensure the relevance of your proposal submission.

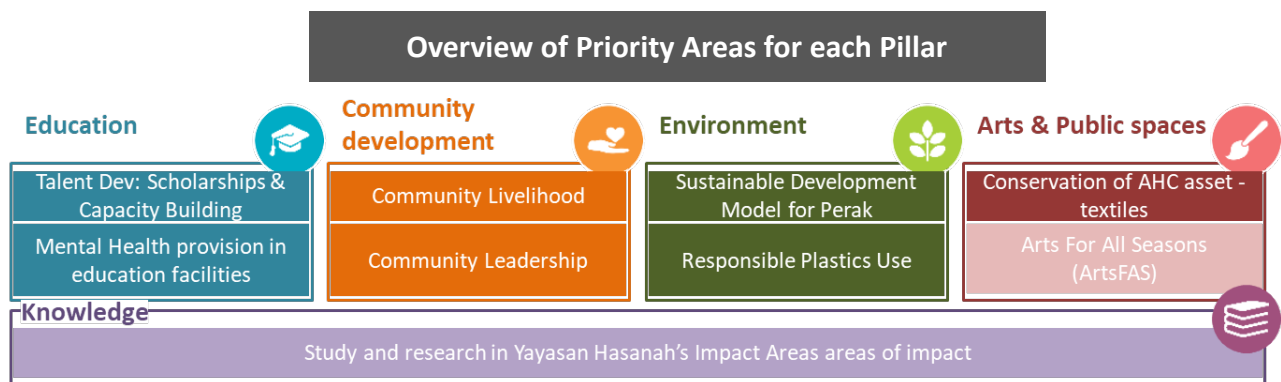

1.2 PRIORITIES WITHIN HASANAH'S IMPACT AREAS

As part of our strategy refresh and Theory of Change for 2021-2025, we have refocused the priorities to drive deeper interventions in each of our Impact Areas. As such, proposals that align to these sets of priorities will see a greater chance of success; therefore we encourage you to read the details to ensure relevance of our proposal to what we are seeking for this grant cycle 2023.



To guide your application, we have included below the objective as well as the scope of projects that we may support for each Impact Area under this year's grant cycle.

COMMUNITY DEVELOPMENT

Objective 1:

Supporting and empowering identified communities that will see a sustained improvement in income and wellbeing through the Hasanah Community Based Approach (CBA) model

Objective 2:

Developing and enhancing community leadership (develop leaders who can self-organize and lead their communities in undertaking collective efforts to improve their quality of life)

Types of projects supported under Objective 1:

Income and Well-being

- Programs that focus on interventions that address poverty, unemployment, and lack of economic opportunities to increase B40 communities' ability to generate income and secure sustained livelihoods within a focused rural or urban communities.
- Programs focusing on upskilling to ensure employments and job placements among community members, especially youths across urban areas, or enhancing entrepreneurial skills in the F&B, agricultural, service sectors or any other skills that will contribute to an increased income or stable employment within a rural community.
- Programs that can demonstrate improved wellbeing and sustained impact within urban or rural communities aligned to Community Based Approach (CBA) model including but not limited to nutrition, education, mental health, access to healthcare which leverages on strategic partnerships with multi stakeholders.

Applicants may opt to include the following projects with proposals submitted under Objective 1 above:

Community Leadership

- Programs that focus on interventions that address poverty, unemployment, and lack of economic opportunities to increase B40 communities' ability to generate income and secure sustained livelihoods within a focused rural or urban communities.
- Programs focusing on upskilling to ensure employments and job placements among community members, especially youths across urban areas, or enhancing entrepreneurial skills in the F&B, agricultural, service sectors or any other skills that will contribute to an increased income or stable employment within a rural community.
- Programs that can demonstrate improved wellbeing and sustained impact within urban or rural communities aligned to Community Based Approach (CBA) model including but not limited to nutrition, education, mental health, access to healthcare which leverages on strategic partnerships with multi stakeholders.

Proposals are welcomed for i) projects under the Income and Well-being category, and ii) projects that combine Income and Well-being and Community Leadership.

Proposals for projects under the Community Leadership category only will not be assessed. We are strictly looking for interventions in the following locations. Proposals outside these locations will not be assessed.

ENVIRONMENT

Objective 1:

Demonstrating a sustainable development model for a state for learning, adoption and advocacy nationwide

Types of projects supported under this objective:

- Co-management of natural ecosystems or restoration of degraded ecosystems with local communities, including Orang Asli, leading towards conservation and protection of ecosystems (forest, freshwater, coastal and marine) and building resilience against climate change
- Programmes involving sustainable alternative financing mechanisms for biodiversity and ecosystems conservation
- Restoration, conservation and protection of critical CFS linkages
- Programmes that involves capacity building, or strengthening collaborative partnership among communities, civil societies, and State/Federal agencies for conservation

Location:

Priority sites in Perak including the Central Forest Spine (CFS) Primary and Secondary Linkages areas, Bukit Larut, Segari Melintang, Pulau Sembilan Marine Area, Lenggong Valley, Kinta Valley Geopark, Ipoh & Kuala Kangsar.

Objective 2:

Advocating a clear responsible plastics agenda with active programme and policy interventions across the value chain

Types of projects supported under this objective:

- Responsible plastic waste management including reduction, segregation, recycling and upcycling that are beneficial to local community and the environment
- Development of micro-entrepreneurs involved in responsible plastic waste management
- Programmes that foster collaboration with relevant stakeholders leading towards improved policies and legislation to support responsible management of plastic waste
- Programmes that inculcate awareness and knowledge on plastic and waste management, with sustainable practices among school children and communities

ARTS & PUBLIC SPACES

Objective 1:

Demonstrating conservation of heritage textiles as a viable creative economic model - Safeguarding, preservation and conservation of Malaysian heritage textiles, creating an outreach and economic platform.

Types of projects supported under this objective:

- Projects that offer preservation, conservation and safeguarding of Malaysian heritage textiles (Telepuk, Kelingkan, Keringkam, Batik, Songket - covering the techniques of weaving, embellishment, painting and printing)
- Projects that promote excellence in heritage textile creation and craftsmanship.
- Projects that increase awareness on heritage textiles.

RURAL INFRASTRUCTURE

Objective 1:

Water initiative

Types of projects supported under this objective:

- Solutions, which are cost effective treatment with uncomplicated maintenance to provide safe drinking water to local communities not connected to the water supply grid
- Solutions, which provides dependable water purification to bring relief and improved comfort to vulnerable and marginalized communities

Objective 2:

Electricity initiative

Types of projects supported under this objective:

- Solutions, which provides cost effective electricity using localized and decentralized sustainable solutions such as solar, hydro, or hybrid to local communities not connected to the electricity grid
- Solutions, which provides a stable and consistent electricity supply to local communities

1.3 GUIDING RULES

The following section sets out the criteria for the submission, selection and implementation of the initiatives supported by Hasanah.

1.3.1. Eligible applicants

Applicant

In order to be eligible for a grant, the applicant must:

- be **legally and locally registered with relevant authorities in Malaysia** (in selected cases, grants may be channeled to organisations registered in foreign jurisdictions but carry out projects in Malaysia and impacting Malaysia):
 - ❖ **Registered organisation under Registrar of Societies Act 1966**; or
 - ❖ **Registered organisation under Companies Act 1965** (Sole Proprietorship, Partnership, Limited Liability Partnership (LLP), Sdn Bhd); or
 - ❖ **Registered Social Enterprises with Ministry of Entrepreneurship and Cooperatives Development (MECD)**; or
 - ❖ **Registered organisation under Trustees (Incorporation) Act 1952**; or
 - ❖ **Registered organisation under Trade Licensing Ordinance (Ordinan Perlesenan Perdagangan) (Sabah) / Business**; or
 - ❖ **Registered organisation under Profession and Trade Licensing Ordinance (Ordinan Perniagaan, Profesion dan Perlesenan Perdagangan) (for Sarawak)**.
- have been **formed and registered at least two years prior to being considered for Hasanah's grant award** – if organisation was previously established under a different name and was operational for at least or more than two years under said name, applicant must provide evidence of such;
- have **audited financial accounts for two consecutive years (over the past 3 years), or copies of annual report submission to Registrar of Societies for two consecutive years or copies of 2 years income tax submission to Inland Revenue Board**;
- be **directly responsible** for the preparation and management of the proposal and **not be acting as an intermediary**;
- track record of working with communities for the past 2 years;
- demonstrate capacity and structures in place to immediately commence the project;
- have an internal audit process for its annual audit.

Other related eligibility criteria

- The applicant may be a co-applicant in another application at the same time
- Applicant can be a social enterprise - defined as organisations or registered companies whose primary mission is to support a social cause, and have a revenue source that is able to sustain their mission
- Public institutions and consultancy may apply as co-applicants with another CSOs as the core applicant

1.3.2. Eligible Projects

Types of activities which may be supported under this Grant Cycle:

Inclusivity

- Activities that target and address the needs of the bottom 50% of underserved, vulnerable and marginalised communities in Malaysia
- Activities that promote social inclusivity, economic empowerment and building of human capital; and are able to restart or generate new economic activities to sustain the community
- Activities with innovative solutions to existing social issues

Service delivery

- Educational and training activities relevant to Hasanah's Impact Areas
- Provision of multidimensional social services, including counselling services (mental wellbeing and psychosocial support to vulnerable communities etc.) and protection of vulnerable women and children

Advocacy and policy

- Preparation and presentation of policy analyses and reports relevant to Hasanah's Impact Areas
- Advocacy initiatives focusing on issues relevant to Hasanah's Impact Areas
- Local campaigns, education of citizens and promotion of principles of transparency, good governance, citizens' participation in decision-making processes relevant to Hasanah's Impact Areas

Capacity building

- In-house mentorship, training, pilot projects, aimed at strengthening the capacities of, civil society organisations ("CSOs") and communities, relevant to issues or problems at the local and national level in Hasanah's Impact Areas

Partnership development

- Identifying and establishing active cooperation with relevant CSO networks, coalitions, think-tanks and individual organisations specialised in issues relevant to Hasanah's Impact Areas
- Networking and partnership building for the purpose of achieving a joint social and entrepreneurial activity

Other eligibility criteria:

- Proposed project must align to one or more of Hasanah's Impact Area(s)
- Proposed activities must demonstrate the ability to produce measurable outputs (short-term results), outcomes (mid-term results) and social impact (long-term results) in a selected Impact Area
- Applicant must demonstrate the ability of the proposed activities to become a sustained part of the community resources upon its completion
- Applicant must demonstrate the ability of the proposed activities to be scaled up or expanded across the various regions within Malaysia and beneficiaries as well as ability to replicate the project
- Proposed activities should be catalytic in nature i.e. should create multi-faceted change in areas that promotes a better future for communities in Malaysia

The following types of initiatives are **non-eligible**:

- Direct donations or grants to individuals
- Initiatives concerned only or mainly with individual sponsorships for participation in workshops, seminars, conference and congress; or for studies or training courses
- Initiatives addressing health problems or any other that are not within Hasanah's Impact Areas
- Initiatives that support political campaigns and/or of political nature
- Initiatives essentially focused on construction activities, purchase of equipment, purchase and/or renovation of building or offices for commercial purposes
- Initiatives aimed predominantly at charitable donations and profit-making activities
- Initiatives which are already funded by another Hasanah's grant and undertaken before the date of contract signature
- Faith-based activities

1.3.3. Eligibility of costs

Hasanah will only support 'eligible costs'. The categories of costs that are non-eligible are indicated below. It is in the applicant's interest to provide a realistic and cost-effective budget.

Ineligible costs

The following costs are not eligible:

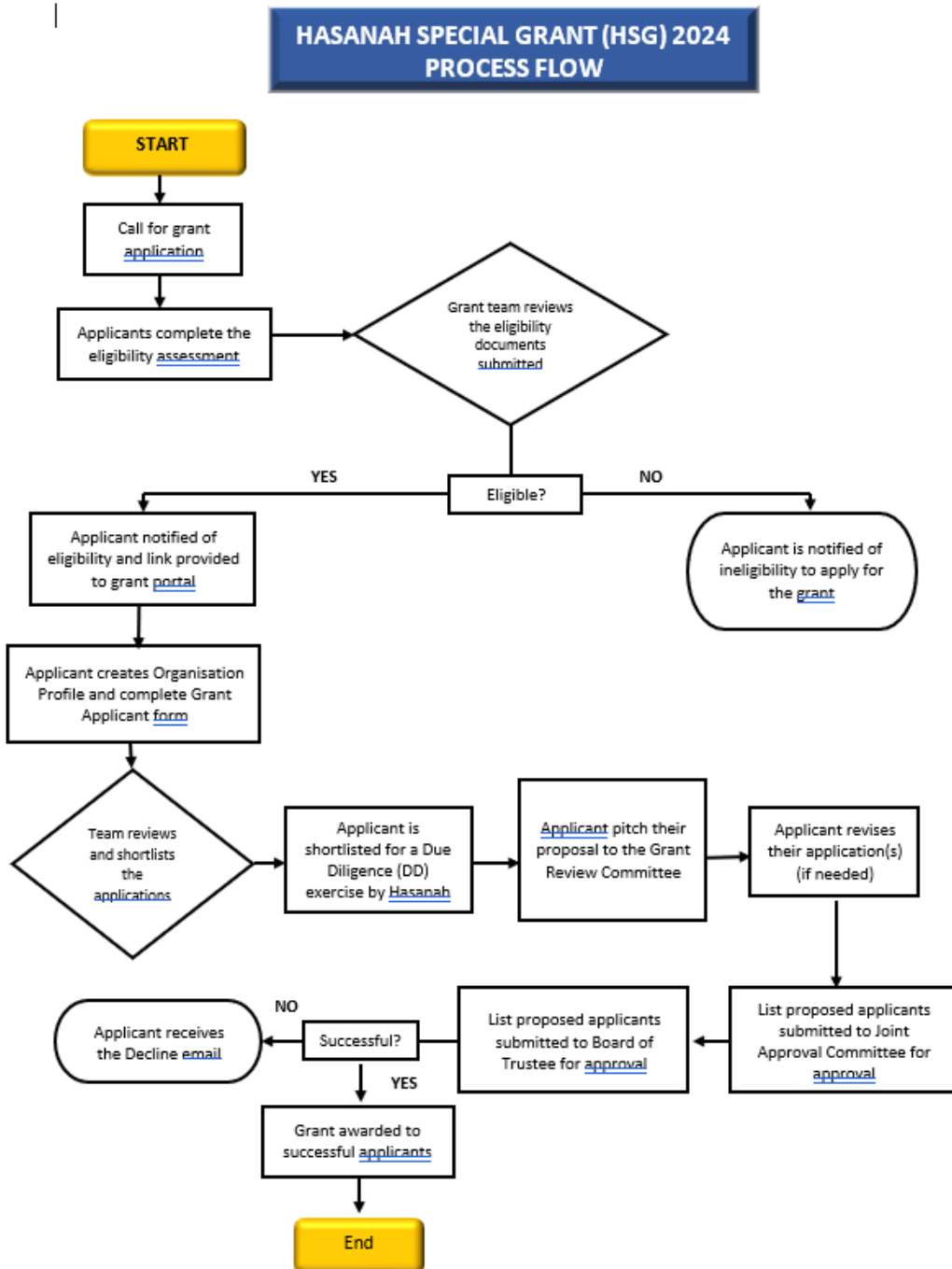
- customs and import duties, or any other charges
- purchase or leasing of land and existing buildings
- fines, financial penalties and expenses of litigation
- bank charges, costs of guarantees and similar charges
- conversion costs, charges and exchange losses, as well as other purely financial expenses
- contribution in kind
- depreciation costs
- debts and debt service charges
- provision for losses or potential future liabilities
- credits to third parties
- salary costs of the personnel of national or public administration

1.4 HOW TO APPLY

Proposals can be received on an on-going basis starting from 16 February 2024 until 15 March 2024 through Hasanah online portal at www.yayasanhasanah.org.

Step 1: Eligibility Assessment

Only eligible applicants will be allowed to submit an application for a Hasanah grant. In order to assess if your organisation would be eligible to apply, please complete the eligibility assessment available on the Hasanah grant portal.

Please ensure that the email you use to submit your eligibility assessment is the same email that you will use throughout this grant application process.

Applicants may access the eligibility assessment once the grant cycle opens. The eligibility of an applicant is based on:

- Being registered with either Registrar of Society (ROS) or Registrar of Companies (ROC) or under the Trustees (Incorporation) Act 1952 or under Trade Licensing Ordinance (Ordinan Perlesenan Perdagangan) (Sabah) / Business; or under Profession and Trade Licensing Ordinance (Ordinan Perniagaan, Profesion dan Perlesenan Perdagangan) (for Sarawak).
- or a period of at least 2 years.
 - If your Organisation is less than 2 years old but was previously established under a different name and was operational for at least 2 years under said name, you will be asked to provide evidence of such.
- Having audited financial accounts for the past 2 years.

Please make sure if you have a copy of your certificate of registration, and most recent audited financial accounts before you start the eligibility assessment.

Your eligibility documentation will be reviewed by our Grants Team.

You will be notified via email if you are eligible to proceed to apply for a grant. All eligible applicants will be invited to register an account on the Hasanah grant portal, and submit their grant applications via Hasanah's online grant portal.

Please ensure that the email you use to register your account is the same email that was used to submit your eligibility assessment.

Step 2: Creating an Organisation Profile

Once you have registered your account on the Hasanah grant portal, you may proceed to create your organisation profile.

Please ensure that the email you provide in your organisation profile is the same email used to register your account on the Hasanah grant portal.

The profile page will contain information about your organisation and previous projects. Step-by-step instructions will be provided on the portal. You may update your profile page at any time.

Step 3: Completing the Application Form

Once you have created your profile page, you can proceed to complete the Application Form. Please complete this carefully and as clearly as possible. Some fields are required and must contain a response. If your response is Not Applicable, you must state it as such.

Any major inconsistencies in the Application Form may lead to a rejection of the application. Full applications must be in English or Bahasa Malaysia.

Only completed Application Form(s) together with accompanying relevant documentation, will be reviewed. It is therefore of utmost importance that these documents contain all relevant information concerning the proposal. These documents are:

- Implementation Plan (available for download at the Grants page of the Hasanah website)
- Budget Breakdown (available for download at the Grants page of the Hasanah website)
- Organisational Structure
- Previous year or current year balance sheet (assets and liabilities) and statement of income and expenses (preferably no more than 3 months old)
- Current operating budget breakdown for the organisation
- Most recent publications, news articles or other relevant materials about the organisation or the project, if applicable (these are optional, non-submission will not affect evaluation of proposal)

You may submit more than one application at each grant cycle.

Applicants may request for further clarification during the application process. **Questions may be sent by email to grant.application@hasanah.org.my no later than three working days before the deadline.**

To ensure equal treatment of applicants, Hasanah cannot give a prior opinion on the eligibility of applicants or a proposal. For a step-by-step guide on how to apply using our online grant portal, please click on the link available on the “Hasanah Special Grant 2024” page on the Hasanah website.

You may also attend Hasanah Outreach Programme that are held preceding the grant application timing to provide you an opportunity to discuss and seek clarification of our application process and tips.

1.5 REVIEW AND SELECTION OF APPLICANTS

Grant applications will be reviewed by the Impact Area teams and respective Grant Managers and deliberated during the Hasanah Grant Committee meeting. During the opening of the cycle, there will be a rolling process of review and approval made on the applications. For example, applications submitted earlier would be reviewed and potentially get the approval earlier.

All applicants will be assessed on:

- Relevance and alignment of projects to Hasanah’s Impact Area(s), specifically our 2024 priorities as stipulated in item 1.2
- Alignment to one or more of the SDGs
- Relevance to communities in need
- Costs and budgets
- Delivery and implementation capacity and capability

The quality of the applications, including the implementation plan and proposed budget, will be evaluated using the evaluation criteria in the evaluation grid below, based on a scoring system between 1 and 5 as follows:

Scoring system 1-5:

1 – poorly developed / below expectations, 2 – needs clarification, 3 – meets basic expectations, 4 – well developed / explained, 5 – great quality of answer / exceeds expectations

Only grant applications with evaluation scores of equal to, or more than 65, will be recommended to proceed to the Due Diligence stage.

1.6 NOTIFICATION OF HASANAH'S DECISION

Impact Area teams, Grant Managers, Monitoring, Learning, Evaluation & Knowledge (MLE&K) teams and Finance team will review the applications. Only shortlisted applications will be informed for the team to conduct Due diligence. Finding from Due Diligence and recommendations will be deliberated at the Grant Committee Review Meeting. Applicants who are shortlisted at the Grant Committee Review Meeting may be asked to revise their application as deemed necessary, prior to being recommended to the Hasanah Board of Trustees for final approval. Following the decision to award a grant, applicants will be offered a contract based on Hasanah's Grant Agreement.

1.7 FUND DISBURSEMENT

Following the decision to award a grant, applicants will be offered a contract, based on Hasanah's Grant Agreement template, which will include the partners' proposal, work plan and reporting schedules.

Hasanah team will be in touch with you to discuss on the grant disbursements according to project timeline, expected deliverables and tranches.

1.8 MONITORING AND REPORTING

All progress updates and final report submissions must be submitted online to a portal using the templates provided by Hasanah.
